2. Justification.

Modification 2. The Degree scientific and professional interest.

The proposal justification for the Plan of studies modification is correct, which is consistent with Annexes attached in the corresponding section on staff, however it is not correct the information of practices.

It is pertinent the updating of the Centre's name, Faculty of Tourism, instead of "University School of Tourism".

It is correct the update of contents and the corresponding evaluation systems, training activities and educational methodologies concerning two of the subjects with a modified workload ("Quantitative methods applied in Tourism" and " Management skills").

6. Academic Staff.

Modification 8. Teaching staff and other human resources.

- The information provided about the academic staff participating in the Master is correct and complete.

7. Material Resources and Services.

Modification 9. External practices agreements, where applicable.

- Evidence provided on enterprises for possible external practices through electronic links.
